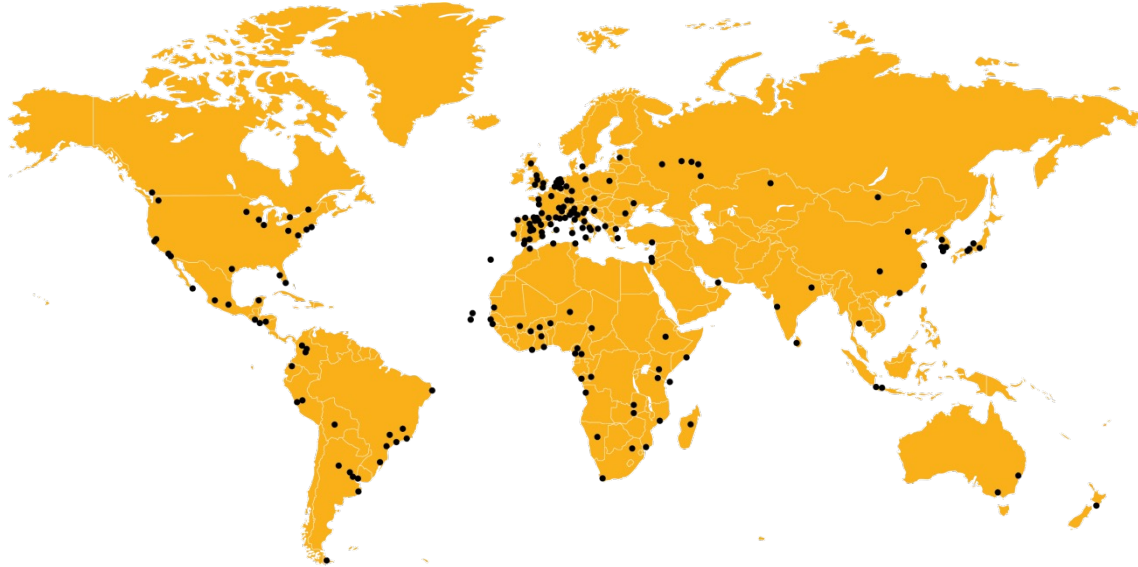

Its main aim is to support cities wishing is fostering **city to city cooperation** and best practices food policies exchange, to develop more sustainable urban food systems.

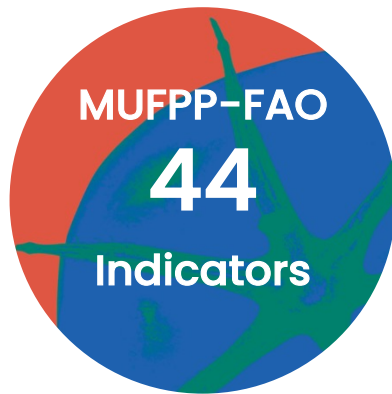
Milan Urban Food Policy Pact tools



Three main tools to strengthen the development of food policies with recommended actions, indications, tools, good practices of the Awards.



The Milan Pact is composed by a preamble and a Framework for 37 recommended actions, clustered in 6 categories. The nature of this framework is to provide strategic options to those cities aiming to develop their food policy. The 37 recommended actions should be seen as entry points towards achieving the common goal of sustainable food systems.



For each recommended action there are specific indicators to monitor progresses in implementing the Pact. The 44 indicators are also followed by a specific Methodological Guidance that describes in detail how collect data. Cities can adapt the indicators to their own context and urban food policy.



The Milan Pact Awards offer concrete examples of the food policies that cities are implementing in each of the 6 Pact categories.

Food Supply & Distribution recommended actions



The 7 recommended actions falling into the “Food Supply & Distribution” are all those actions want to ensure a sustainable, safe, fair, continuous and efficient supply and distribution of food into and within cities. For example: to review and strengthen food control systems, to ensure seasonal and local food consumption by linking peri-urban and near rural areas transport and logistics, to develop green public procurement and trade policy to facilitate short food supply chains, to support for municipal public markets, to support for municipal public markets.

27. **Assess the flows of food to and through cities** to ensure physical access to fresh, affordable foods in low-income or underserved neighbourhoods while addressing sustainable transportation and logistics planning to reduce carbon emissions with alternative fuels or means of transport
28. **Support improved food storage, processing, transport and distribution** technologies and infrastructure linking peri-urban and near rural areas to ensure seasonal food consumption and reduce food insecurity as well as food and nutrient loss and waste with an emphasis on diversified small and medium scale food businesses along the value chain that may provide decent and stable employment
29. **Assess, review and/or strengthen food control systems** by implementing local food safety legislation and regulations that (1) ensure that food producers and suppliers throughout the food chain operate responsibly; (2) eliminate barriers to market access for family farmers and smallholder producers; and (3) integrate food safety, health and environmental dimensions.
30. **Review public procurement and trade policy** aimed at facilitating food supply from short chains linking cities to secure a supply of healthy food, while also facilitating job access, fair production conditions and sustainable production for the most vulnerable producers and consumers, thereby using the potential of public procurement to help realize the right to food for all.

Food Supply & Distribution recommended actions



The 7 recommended actions falling into the “Food Supply & Distribution” are all those actions want to ensure a sustainable, safe, fair, continuous and efficient supply and distribution of food into and within cities. For example: to review and strengthen food control systems, to ensure seasonal and local food consumption by linking peri-urban and near rural areas transport and logistics, to develop green public procurement and trade policy to facilitate short food supply chains, to support for municipal public markets, to support for municipal public markets.

31. **Provide policy and programme support for municipal public markets** including farmers markets, informal markets, retail and wholesale markets, restaurants, and other food distributors, recognizing different approaches by cities working with private and public components of market systems.
32. **Improve and expand support for infrastructure** related to market systems that link urban buyers to urban, peri-urban and rural sellers while also building social cohesion and trust, supporting cultural exchange and ensuring sustainable livelihood, especially for women and young entrepreneurs.
33. **Acknowledge the informal sector's contribution** to urban food systems (in terms of food supply, job creation, promotion of local diets and environment management) and provide appropriate support and training in areas such as food safety, sustainable diets, waste prevention and management.

Indicators Methodological Guidelines

To facilitate the use of Indicators, a set of Methodological Guidelines has been developed for each indicator. Each guideline contains information on:

- the **rationale** for selecting this indicator
- how the indicator is constructed
- a **glossary** to clarify technical terms
- explanations on the **types of data** required
- **how data can be collected**
- the expertise and **resources needed**
- **examples** of how some cities have already collected and analyzed data and used this indicator.

Each guideline also highlights the connections with the **SDGs** and **targets**.

Cities can select, adapt and group options into guidelines as necessary to suit their situations.

Food Supply & Distribution indicators

Despite the growing number of urban food initiatives in many cities, a key challenge expressed by MUFPP signatory cities is measuring the impact of these policy processes and initiatives. Since 2016, FAO and the MUFPP Secretariat, with the support of the RUAF, developed an innovative and comprehensive set of indicators and methodological guidelines to monitor the MUFPP recommended actions.

- 34: Existence of policies/programmes that address the reduction of GHG emissions in different parts of the food supply chain**
- 35: Presence of a development plan to strengthen resilience and efficiency of local food supply chains logistics**
- 36: Number of fresh fruit and vegetable outlets per 1000 inhabitants (markets and shops) supported by the municipality**
- 37: Annual municipal investment in food markets or retail outlets providing fresh food to city residents, as a proportion of total (investment) budget**
- 38: Proportion of food procurement expenditure by public institutions on food from sustainable, ethical sources and shorter (local/regional) supply chains**
- 39: Presence of food safety legislation and implementation and enforcement procedures**
- 40: Existence of support services for the informal food sector providing business planning, finance and development advice**

Barcelona – *Green Commerce*

- 39 municipal markets, 1000 market stalls in the city
- a reference point for sustainable and quality food for citizens
- incentives provided to business that comply to sustainability requirements
- 600 market stalls have been classified as *comercios verdes*

Indicator 36 Number of fresh fruit and vegetable outlets per 1000 inhabitants (markets and shops) supported by the municipality.



Lyon – *Relocating the Diet of the Inhabitants*

- a joint policy aimed at **improving food resilience and justice** to strengthen the territory's **food autonomy**
- public procurement with a target of **100% organic products** and **50% local products** in school canteens
- organisation of **events for professionals** to bring together local buyers and sellers
- a **collaborative map** to inform residents about the local food supply available
